AGREEMENT: Space provided will be designated by the Main Street Promotions Committee. Set-up must be completed no later than 9 a.m., Saturday, October 16, 2010. Concessionaire will provide own mobile unit and other equipment that may be necessary for concession operation. Concessionaire hereby agrees to sell only those items approved for sale by the Main Street Promotions Committee and will police assigned area completely.

CONDITIONS:

- A. Concessionaire, employees, and other representatives, will comply with all general rules and regulations prescribed by sponsor.
- B. All installations erected by the concessionaire shall be subject to the approval of the Main Street Promotions Committee.
- C. Concessionaire shall not transfer or sublet the space or any part thereof or permit the same to be used by any other person without the prior written consent of the Main Street Promotions Committee.

- D. The Main Street Promotions Committee shall have the right to terminate the contract granted hereunder at any time without liability upon the refund or the fee paid herewith. No refunds, regardless of weather, will be made.
- E. The Main Street Promotions Committee shall have full access to the space covered in this contract at all times.
- F. Concessionaire will keep booth open throughout the entire event during the hours of 10:00 a.m. to 4:00 p.m., Saturday, October 16, 2010. Dismantling of the booth will not take place before the official end of the event without the prior approval of the Main Street Promotions Committee.
- G. Concessionaire will indemnify and hold the Main Street Promotions Committee, Main Street Board Members, employees, volunteers, or the City of West Memphis harmless from all costs, losses, damages, or expenses including loss of litigation, and attorneys' fees, resulting from any loss, injury, or damage real or asserted, to any person or property arising out of any act or omission of exhibitor or his employees or other representatives.
- H. The Main Street Promotions Committee and its officers, agents or members, or the City of West Memphis, shall not be held responsible for any loss or damage due to theft, fire, accident, or other causes, but will use reasonable care to protect the concessionaire from such loss.
- I. The concessionaire will completely set up booth by 9 a.m. Saturday, October 16, 2010, and will remove all property and all structures placed on the space by concessionaire and will surrender the space in the same condition, except for the natural wear and tear and damage not resulting from this contract, as at the beginning thereof. The area should be cleared no later than 9 p.m. on Saturday, October 16, 2010, unless otherwise approved in advance by the Main Street Promotions Committee.
